- 1. Name of Goods, works, services:** supply of AZS blocks for furnace №5.
  - 2. Method of conducting the trade procedure:** simple purchase (collecting commercial offers).
  - 3. Address of delivery of Goods, works, services:** 8a, Dargomyzhskogo, Novosibirsk, Russia.
  - 4. Condition of delivery of Goods, work, services (terms, schedules, packaging, labeling):**
    - FOB of loading for Chinese and Indian companies, FCA for European and Russian companies.
    - Time of supply – 120 days from the date of prepayment. Delivery date - third decade of January 2020.
- Packaging requirements:**
- Packaging of Goods must ensure the safety of the goods in the conditions of transportation by all modes of transport. Packaging should protect the goods from any kind of damage, loss of presentation during its transportation.
- 5. Form, terms and procedure of payment for goods, work, services. The procedure for the formation of the contract price (lot price) (including or excluding transportation costs, insurance, payment of customs duties, taxes and other mandatory payments):** 30% advance payment; 60% after the signing of the act of acceptance of the stand pre-assembly of products in the warehouse of the supplier, 10% after the signing of the act of acceptance of products in the warehouse of the buyer.
- The price is provided by the participant of the competition with a breakdown by brand of material, fixed and is not subject to change until the end of the contract

  - 9. Requirements to the complete set:** according to the Ordered specification: glass contact, Ordered specification: superstructure.
  - 10. Requirements to the quality:** according to the "Technical requirements for the quality of fused-cast refractory products of the AZS brand".
  - 11. Requirements for installation, commissioning, acceptance tests:** without installation.
  - 12. Requirements for manufacturer's warranty and after-sales service conditions:**

- supplier guarantees the conformity of production with the "Technical requirements for the quality of fused-cast refractory products of the AZS brand".
- the supplier provides a guarantee for products for a period of 30 months.
- the supplier provides the manufacturer's liability insurance for the amount of the cost of the Goods for the duration of the warranty.
